LGBTQ+ URMs often encounter compounded discrimination and are disproportionately affected by violence, homelessness, and lack of access to essential services. Considering the uni

que challenges these individuals face, it is crucial to prioritize support within this community to create safe and affirming environments for youth to thrive. This webinar is designed to equip URM service providers with the knowledge and tools needed to effectively address these disparities. By focusing on actionable strategies for fostering inclusivity, implementing LGBTQ+ affirming placements, and offering client-centered guidance and resources, participants will be empowered to play a pivotal role in creating safer and more supportive environments for all LGBTQ+ URM clients.

"Join us for a webinar on PRAIDA, the only institutional Canadian program for the reception and integration of asylum seekers, boasting over 60 years of expertise in working with migrant populations in Quebec. The program has adapted over time to various migration waves and changes in Canadian and American immigration policies. More recently, the additional protocol to the Safe Third Country Agreement (STCA) has raised new issues, particularly regarding access to asylum. Its application along the entire Canada-U.S. border has impacted the profile of the clientele served and traditional migration routes, necessitating new responses to address these challenges. This webinar will outline the unprecedented situation Canada is facing concerning the arrival of asylum seekers and how PRAIDA has adeptly adapted to meet the needs of these individuals.

His academic and professional journey has led him to study the causes and mechanisms of irregular migration and its various routes.

Karissa is social worker with experience in child protection and refugee care, currently working within the Integrated University Health and Social Services Centres in Montreal, Quebec. She completed her undergraduate degree in International Development Studies and Political Science and proceeded to work in prevention, aftercare, and reintegration programs in the field of anti-trafficking in Cambodia. After completing her Master's degree in social work at McGill University in 2019, Karissa began her career at the Regional Program for the Settlement and Integration of Asylum Seekers (PRAIDA). She spent 4 years working on PRAIDA's team for unaccompanied minors, offering a psychosocial follow up from their arrival into their settlement in Quebec. She now holds the position of team leader, building on her skillset of intercultural intervention, trauma-informed care, and clinical support. Passionate about developing meaningful cross-sectoral partnerships and understanding global migration trends, she is devoted to developing processes and applying best practice to support unaccompanied and separated children in their integration into Canada."

"What will this webinar cover?"

During resettlement, newcomer caregivers face numerous challenges adjusting to their new cultural context, which can significantly affect their caregiving practices for children and youth. Although some families receive a brief cultural orientation upon arriving in the United States, further education on U.S. child welfare policies, positive parenting strategies, and parental rights and responsibilities is essential to prevent misunderstandings. Providers working with newcomer caregivers must understand the inherent difficulties of parenting in a new culture and approach caregiving topics with sensitivity. This webinar will address cultural adaptation barriers that impact parenting decisions, offer strengths-based and trauma-informed strategies for educating newcomer parents on their caregiving rights and responsibilities, and provide positive parenting recommendations.

This webinar is designed for direct service providers, school staff, and agency leaders who work with newcomer caregivers and families.

"Switchboard is pleased to announce a free online certificate course on *Fundamentals of Trauma-Informed Casework Supervision of Refugee Service Providers*, which will meet in four 90-minute sessions on Thursdays from August 15 to September 5, 2024:

This course is among the first [National Association of Social Workers](https://www.nasw.org)-accredited Switchboard courses! Upon successful completion of the course requirements, you will earn 10 continuing education units/credits that can be applied to your professional licensure.

### What will this certificate course cover?

Refugee service providers work in a dynamically evolving and trauma-exposed environment. Casework supervisors, especially those new to their roles, can find it difficult to navigate these challenges while supporting their teams. In this certificate course, you will learn about the widespread impact of trauma in resettlement work and how to recognize the signs and symptoms as they show up in your staff. By completing the course, you will gain a pragmatic framework for building an effective cross-cultural, trauma-informed approach to casework supervision.

### Is this certificate course for me?

This course is geared toward managers and supervisors interested in improving their trauma-informed support and supervision skills. The course will be most relevant for casework supervisors and managers who have been in their roles between six and 18 months. Participants are expected to bring a foundational skillset in case management and a basic understanding of their core roles and responsibilities as supervisors. *This course will not cover the basics of case management.*

### Why should I participate?

Upon completing this course, learners will be able to:

- Describe three key fundamentals of casework supervision in the context of services for newcomers
- Describe potential impacts of trauma in casework and apply practical skills in **trauma-informed** supervision
- Apply practical skills in **culturally aware** supervision, including strategies that consider socio-cultural context

- Apply practical skills in **supportive** supervision, including strategies for staff care and self-care

## Eligibility

The course is open to 50 staff members who serve ORR-eligible populations, including at state agencies, resettlement agencies and affiliates, and ethnic community-based organizations. Applicants must currently supervise at least one caseworker, case manager, or similar position. Applicants are expected to seek full support from their supervisor/director for course participation prior to submitting an application.

## Format

This course is designed to be completed by individual participants. Multiple staff members from the same organization may individually apply for the course. In a combination of four live workshops and independent activity, the total time commitment will be approximately **10 hours** over four weeks from August 15 to September 5, 2024. The synchronous sessions will not be recorded to provide all learners with maximum comfort and interactivity.

We are reaching out today to let you know that the Asylum Program Division of Immigration, Refugees and Citizenship Canada (IRCC) is offering technical briefings on asylum claim processes. The technical briefing was developed to help front-line workers and government organizations gain a better understanding of the procedures involved in processing claims submitted by asylum seekers, as well as the supports and services they may be able to access while their claim is being processed. Please note that the information sessions are geared towards front-line workers and public servants from various community organizations and municipal, provincial and other governmental organizations who work with asylum seekers. Our briefings are virtual, via MS Teams, and last about 30 minutes. We also allow time after the presentation for questions. Below is an overview of what is covered.
